Who we are

The V&A is a family of museums dedicated to the **power of creativity**. Our mission is to **champion design and creativity** in all its forms, advance cultural knowledge, and inspire makers, creators and innovators everywhere. We share a 5,000-year-old story of creativity through **exhibitions, events, educational programmes, digital experiences, conservation, research**, and an ever-evolving national collection of over 2.8m objects spanning **every creative discipline**.

The V&A is currently undertaking a major Technology Enablement Programme to modernise its enterprise and commercial technology landscape. The programme includes re-platforming CRM, e-commerce, and ticketing systems, implementing robust data governance, and introducing AI-driven automation.

This role will be instrumental in leading enterprise-wide discovery, defining the as-is and to-be landscapes, and producing a roadmap to support sustainable change across systems, data, and business processes.

About the role

The Business Architect will lead the analysis and design of business processes, systems, and data flows across the V&A, with a focus on both Commercial and wider Enterprise domains. The role bridges strategic intent with operational delivery, ensuring that all change initiatives are cohesive, AI-enabled, and aligned with the V&A's strategy.

Key Responsibilities

Enterprise-Wide Discovery & Architecture Definition

- Lead enterprise-wide discovery activities to capture current-state systems, data flows, and business processes across all departments
- Produce as-is and to-be architecture artefacts, including capability models, user journeys, and data maps
- Identify gaps, duplication, inefficiencies, and transformation opportunities

Business Architecture & Strategic Alignment

- Define and evolve business capability models and operating models
- Ensure alignment between departmental transformations and the overarching enterprise architecture
- Assist in shaping business cases, benefit realisation frameworks, and strategic plans

Data & Integration Strategy

- Partner with Enterprise and Data Architects to develop a unified data model and integration blueprint across CRM, ERP, ticketing, and e-commerce systems
- Conduct data maturity and governance assessments to support reporting, AI, and automation readiness

Governance & Framework Development

- Support the development of the Technology Centre of Excellence, Technical Design Authority and other governance forums
- Define roles, decision-rights, and standards to govern processes, platforms, and data use across the organisation

AI-Enabled Process Optimisation

- Identify and prioritise processes for AI-first redesign and automation (RPA, decision support, predictive analytics)
- Collaborate with stakeholders to pilot and scale AI use cases that enhance efficiency and insight generation

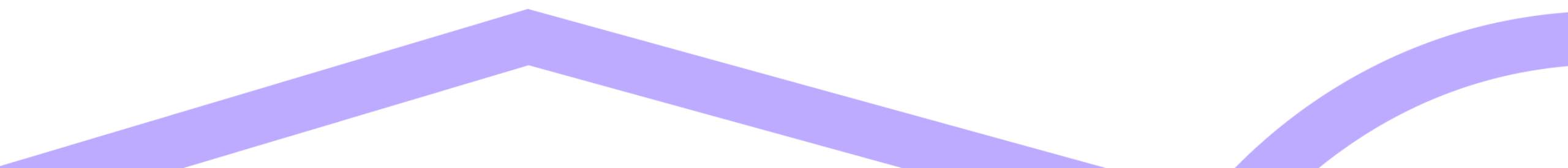
Requirements Gathering & Solution Shaping

- Collaborate with product managers, architects, and technology partners to translate business needs into scalable solution designs
- Ensure requirements are well-documented, technically feasible, and aligned with strategic goals

Stakeholder Engagement & Change Leadership

- Facilitate cross-departmental workshops to build alignment and shared vision
- Communicate progress, risks, and recommendations clearly to senior leadership
- Support change management by documenting changes and training key user groups

 - Familiarity with enterprise architecture and business transformation frameworks (e.g., TOGAF)
 - Process Mapping & Analysis: Proficient in BPMN/UML and translating business operations into structured models
 - Business Architecture Thinking: Skilled in building and applying capability models and value streams
 - Data & Integration Strategy: Ability to assess data quality, governance, and support systems integration
 - Documentation & Communication: Competent in creating business requirements, specifications, and roadmap materials
